About The Authors

JANET MANCINI BILLSON is Professor of Sociology at Rhode Island College, Providence. She is Director of Group Dimensions, a private consulting firm specializing in group facilitation and assertiveness skills training. A member of CSA since 1978, she received her M.A. and Ph.D. in sociology from Brandeis University and her baccalaureate in sociology and psychology from Baldwin-Wallace College. Billson is the author of Strategic Styles: Coping in the Inner City and the editor (with F. Robbins) of Encountering Society: Introductory Readings in Sociology. She also edited In the Wake of the Mills: Central Falls, R.I.

KENNETH COLBURN, JR. In addition to his full-time appointment in the Department of Sociology, Indiana University—Purdue University, the author has been partners with Gary Voelkl in the founding and practice of the Family Therapy Center, Indianapolis. In addition to theory, Colburn's areas of research and teaching are social psychology and the family.

JONATHAN A. FREEDMAN is Director of Education and Training at Hutchings Psychiatric Center, Syracuse, New York. He is the current President of the Clinical Sociology Association and co-authored the first text in the field, *Clinical Sociology*. He is an adjunct faculty member at Syracuse University, Upstate Medical Center, New School for Social Research, and Empire State College.

JOHN F. GLASS, Ph. D. (UCLA), is a founding member and the first President of the Clinical Sociology Association. He is adjunct faculty member in the Human Resources and Organization Development Program at the University of San Francisco, and has a consulting practice specializing in organization development. Glass is an Associate Editor of *CSR* for 1985.

KATHRYN L. GOLDMAN received her Ph.D. in sociology from Columbia University and is currently Adjunct Professor of Administrative Science at the Naval Postgraduate School, Monterey, California. She conducts stress workshops for individuals and corporations; her specialty in sociology is organization development.

DOUGLAS B. GUTKNECHT currently directs the M.S. degree program in Human Resource Management Development at Chapman College, Orange, California. The graduate program integrates clinical sociology, organizational development, health and wellness enhancement, conflict resolution, and

human resource development courses. Gutknecht has consulted with several local organizations and corporations in the areas of stress management, organizational development, and human resource development. He is the author of *Meeting Organization and Human Resources Challenges: Issues and Strategies* and *Creative Development of Organizational and Human Resources: A New Era Reader* (forthcoming, 1984).

BERNIE JONES received his B.A. in sociology and psychology (1965) and his M.A.in social psychology (1968) from the University of Missouri at Kansas City. Before completing the Ph.D. in sociology (University of Colorado, 1973), he established Social Change Systems, Inc., a consulting firm in social research, education, and action. Between 1969 and 1980, he conducted projects for design and planning firms, neighborhood groups, government agencies, and religious and educational organizations. Specific tasks involved conducting community surveys, training projects, social impact assessments, program evaluations, and troubleshooting consultations. His emphasis has been on demystifying and democratizing the social research process. At present, Jones is Research Director at the Center for Community Development and Design at the University of Colorado at Denver, where he also holds an appointment as Associate Professor of Planning and Community Development.

DAVID J. KALLEN is Professor of Pediatrics/Human Development in the College of Human Medicine at Michigan State University. A Ph.D. in social psychology from the University of Michigan, he has also worked as Research Director of the Health and Welfare Council of the Baltimore Area and as a Health Scientist Administrator in the National Institute of Mental Health and the National Institute of Child Health and Human Development. He has published in a variety of fields, including nutrition and development and sexual behavior of adolescents. He is currently a Vice President of the Clinical Sociology Association.

JAMES A. KENT organized the Foundation for Urban and Neighborhood Development (FUND) in 1967 as a nonprofit corporation to address the need to develop practical approaches to preventing social disharmony in society. In 1982 he started SRM (a profit company) to continue the consulting work of FUND. His approach to resolving social issues led to the early development of a training approach designed to develop people's capabilities to predict and thereby control their environment. As Executive Director of FUND, he has worked with professional groups, government agencies, Native Americans, rural communities, and urban neighborhoods to design social impact management systems that maintain local control while accommodating development and change in social and economic conditions. A sociologist and lawyer, Kent

developed procedures for the U. S. Forest Service for day-to-day management and forest planning that facilitate resource use decisions based on knowledge of local issues. He received a B.A. in human relations, Salem College, West Virginia, an M.B. in sociology, Kent State University, and a J.D., University of Denver, Colorado.

ALFRED McCLUNG LEE, past President of the American Sociological Association, is Professor Emeritus of Sociology, City University of New York; has served as Visiting Scholar at Drew University; and is a founding member of the Association of Humanist Sociologists, the Society for the Study of Social Problems, and the Clinical Sociology Association. Author, coauthor, and editor of numerous books and articles, Dr. Lee has recently published Terrorism in Northern Ireland. Other books include Toward Humanist Sociology and Sociology for Whom?

BETTY REID MANDELL, Associate Professor and Chair, Department of Social Work, Bridgewater State College, combined an undergraduate degree in sociology with a Master's degree in religious education from Union Theological Seminary and an M.S.W. from Columbia School of Social Work. Mandell is co-author, with Barbara Schram, of *Human Services: An Introduction*.

LEO MILLER, Professor Emeritus of Sociology at Rhode Island College, received his Master of Science in Social Service from Boston University School of Social Work, an M.Ph. from Harvard School of Public Health, and a Ph.D. in Sociology from Syracuse University. His career has spanned social work, public health, and sociology through his numerous publications, research, teaching, consulting, and case work.

KEVIN PREISTER, since joining Foundation for Urban Neighborhood Development in 1979, has worked on numerous projects related to social impact assessment, retraining, and consultation. He was field director for the social impact assessments for the Adam's Rib Recreational area and the Homestake II Water Diversion Project in western Colorado. Preister has been active in FUND's training programs for improving the social understanding and responsiveness of government and corporate clients, including the oil and gas industries, the Philippine Ministry of Forestry, and public utility companies. He has worked on a Denver cable franchise effort to develop a grant program for community ownership and investment potential offered through low-cost company shares.

In January 1983, Preister opened a northwest divisional office for FUND in Ashland, Oregon. He is offering services and training programs related to

water development, chemical waste, energy development, and alternative energy development. He earned his B.S. in psychology at Colorado State University and an M.S. in anthropology at Catholic University of America.

THOMAS J. RICE is Assistant Professor of Sociology at Georgetown University. A member of the American Sociological Association's Project on Graduate Teaching, he is also a consultant for the Project's Teaching Resource Group. He is active in the Association for Work Place Democracy.

ROGER A. STRAUS is on the faculty of Alfred University, Alfred, New York. An early member of CSA, Straus is the editor of the forthcoming *Using Sociology: An Introduction from the Clinical Perspective*, an Association project. He is the author of *Strategic Self Hypnosis*, which incorporates a symbolic interactionist perspective into the practice of hypnotherapy. Straus received his M.A.and Ph.D. from University of California at Davis.

JEAN H. THORESEN, Associate Professor of Sociology and Applied Social Relations at Eastern Connecticut State University, is interested in the relationship between theory and therapeutic practice. Her recent focus is on clinical issues in working with gay couples. She earned an M.A. in sociology from the University of Connecticut and an M.S. in human relations from ECSU.

GARY M. VOELKL, Department of Sociology, Indiana University-Purdue University, specializes in medical sociology. He is co-director of the Family Therapy Center in Indianapolis, a sociologically oriented therapeutic center for both individuals and groups.
