ABOUT THE AUTHORS

Richard M. Allman, M.D., “Satisfaction with Medical Encounters Among Caregivers of Geriatric Outpatients,” is an Associate Professor of Medicine, Director of the Division of Gerontology and Geriatric Medicine, Director of the Center for Aging, and Chief of Geriatric Medicine, Department of Veterans Affairs Medical Center in Birmingham, as well as the Curriculum Development and Evaluation Coordinator for the Primary Care Training Program at the University of Alabama at Birmingham. He completed his M.D., internship, and residency in Internal Medicine at West Virginia University and then served as a fellow in General Internal Medicine at Johns Hopkins University. He serves as an Associate Editor for the *American Journal of Medicine*.

Share DeCroix Bane, M.E.D., “The Rural Elderly: Providers’ Perceptions of Barriers to Service Delivery,” has 19 of years experience in the field of aging. She has worked in the area of program development and design as an educator and consultant. As director of the National Resource Center for Rural Elderly, she coordinated education, research, and technical assistance targeted to providers of services to the rural elderly. She is working with C. Neil Bull on a Retirement Research Foundation grant looking at the older rural volunteer.

Julia E. Bradsher, Ph.D., “Economic Diversity and Informed Old Age Social Policy,” received her M.S. in social gerontology and counseling from Baylor University in 1986 and her Ph.D. from the University of Miami in 1992. She now holds the Pew Post-doctoral Fellowship in the Institute for Health Policy Studies and the Institute for Health and Aging at the University of California at San Francisco. In the late 1980s, she was a staff gerontologist in the Governor’s Office of Federal-State Programs, Department of Human Development, Jackson, Mississippi, and staff resource person on health and mental health policy. She was a student member of the Public Policy Committee of the Gerontological Society of America and a Summer Research Fellow of the Institute of Gerontology at the University of Michigan during her doctoral studies.

C. Neil Bull, Ph.D., "The Rural Elderly: Providers' Perceptions of Barriers to Service Delivery," graduated from the University of Oregon in 1971 specializing in the area of the sociology of leisure and has since been a faculty member and chair of the Department of Sociology at the University of Missouri-Kansas City. From 1974-76 he held a Midwest Council for Social Research on Aging (MCSRA) Postdoctoral fellowship which led to his collaboration on an Andrus Foundation grant looking at the role of the older volunteer. Building on this work he began to look at the role of retired academicians, and the role of the rural pharmacist in helping the rural elderly overcome drug interactions. He also evaluated programs aimed at the rural elderly. This move to research on the rural elderly led to his role as a Co-Director of the Center on Rural Elderly, a clearinghouse for rural educational program materials funded since 1987 by the Kellogg Foundation. As Principle Investigator of a grant to set up the National Resource Center for Rural Elderly, he has helped guide the publication of sixteen monographs on many varied academic and applied subjects dealing with the delivery of services through the rural aging network. After a six-month leave in 1989 to look at the rural elderly in Australia, he has completed an MCSRA publication due for fall 1993 publication by Sage Publications and titled *Aging in Rural America*. He has also completed for Greenwood Press a volume titled *The Older Volunteer: An Annotated Bibliography*, to be published in April 1993. At present, he is working on a Retirement Research Foundation grant to study the older rural volunteer.

Jeffrey Michael Clair, Ph.D., "Satisfaction with Medical Encounters Among Caregivers of Geriatric Outpatients" and "The Medical Sociologists' Contribution to the Interdisciplinary Geriatric Assessment Unit: A Sociology 'With' Medicine," is an Assistant Professor of Sociology and Medicine serving in the Department of Sociology, the Division of General and Preventive Medicine, and the Division of Gerontology and Geriatrics, at the University of Alabama at Birmingham. He is also the Director of the Social and Behavioral Sciences and Center for Aging Gerontology Education Program. His current applied experience includes work as the Medical Interviewing Preceptor for the Primary Care Training Program. He completed an N.I.A. Postdoctoral Research Fellowship in Health and Aging at the Andrus Gerontology Center, University of Southern California, after completing his Ph.D. in Sociology at Louisiana State University with a National Science Foundation Dissertation Research Award for a study on doctor-patient-family communication. His substantive areas of specialization are medical sociology, gerontology, social psychology, and triangulated research methods.

Harold Cox, Ph.D., "History of Social Gerontology," received his Ph.D. from Indiana University in 1972. He is currently chair of the Department of Sociology at Indiana State University. He has published several articles and two books on gerontology. His text, *Later Life: The Realities of Aging*, published by Prentice Hall, is in its third edition.

His research focuses on health practices and illness behavior in older adults, and perceptions of chronic illness across the adult life span. His publications include articles on such aspects of gerontological health as geriatric assessment, health practices across the adult life span, coping with chronic illness, and the role of family in health care decisions of older adults.

Matilda White Riley, D.Sc., "Aging in the Twenty-First Century," is the Senior Social Scientist at the National Institute on Aging, National Institutes of Health, following a decade as Associate Director of NIA for Behavioral and Social Research. She is Professor Emerita of Sociology, Rutgers University, and Bowdoin College. She was 1986 President of the American Sociological Association and 1985 Co-President (with John Riley) of the District of Columbia Sociological Society. In recent years she has been a Fellow of the Center for Advanced Study in the Behavioral Sciences, and has held a number of offices, including President of the Eastern Sociological Society, Chairperson of the Research Committee of the Advancement of Science, Chairperson of the Committee on Life-Course Perspectives on Middle and Old Age of the Social Science

Research Council, and Chairperson of the American Sociological Association Section on Aging. She is a senior member of the Institute of Medicine (National Academy of Sciences) and a member of the American Academy of Arts and Sciences. She received the Radcliffe Alumnae Recognition Award (1982); an honorary L.H.D. from Rutgers University (1983); the Commonwealth Award in Sociology (1984); the Gerontological Society of America Distinguished Creative Contribution to Gerontology Award (1990); the Kent Award (1992); the Meritorious Rank Award from the President of the U.S. (1990); and the American Sociological Association Distinguished Career Award for the Practice of Sociology (1992). Her book publications include: *Sociological Research* (2 volumes, 1963); *Aging and Society* (3 volumes, 1968-1972); *Aging from Birth to Death*, American Association for the Advancement of Science (Volume I, 1979; Volume II, 1982); *Aging in Society* (co-editor, 1983); *Perspectives in Behavioral Medicine: The Aging Dimension* (co-editor, 1987); *The Oldest Old* (co-editor, *Milbank Quarterly*, 1985); *Social Change and the Life Course* (2 volumes, 1988); *AIDS in an Aging Society* (co-editor, 1989); and *The Quality of Aging: Strategies for Interventions* (co-editor with John W. Riley, Jr., *The Annals*, 1989). Dr. Riley has worked and published extensively in research methodology, communications research, socialization and intergenerational relationships, and the sociology of age. She is listed in *Who's Who in America* and *Who's Who in the World*.

Ferris J. Ritchey, Ph.D., "Satisfaction with Medical Encounters Among Caregivers of Geriatric Outpatients," is Associate Professor in the Department of Sociology at the University of Alabama at Birmingham, with secondary appointments in the Department of Health Services Administration and the Center for Health Risk Assessment and Disease Prevention. He received his doctorate from the University of Texas at Austin. He has published in major medical sociology, medicine, public health, clinical pharmacy and physical therapy journals. He is most recognized for his research on changing role relationships among health professionals, and for his work on the health of homeless persons.

Dr. Rosenberg's current research interests include aging, chemical dependency, mental health, and sport sociology.

Karen L. Scott, M.D., M.P.H., "Health Policy Development: Health Promotion and Illness Prevention Among Older Adults in Illinois," is the Director of Cook County Department of Public Health in Illinois and is an Assistant Clinical Professor for Stritch School of Medicine at Loyola University in Illinois. She has served as President of the

Illinois Public Health Association (1991-1992) and Council Member of Medical Services for the Illinois Medical Society. She received her M.D. degree from the University of Washington specializing in Pediatrics and her M.P.H. from the University of California at Berkeley.

Arthur B. Shostak, Ph.D., "The Older Person as Mediator between Technology and Environment: Toward the role of 'Technoguide'." Since earning a Ph.D. in Sociology in 1961 (Princeton), Art Shostak has taught at the University of Pennsylvania (1961-67) and Drexel University (1967 to date). His 15 books include such titles as *Modern Social Reforms*, *New Perspective on Poverty*, *Sociology in Action*, *Putting Sociology to Work*, *Blue Collar Life*, *Robust Unionism*, and *Men and Abortion*. Chairman in 1989 of the Sociological Practice Section of the American Sociological Association, he has spoken often for a wide variety of gerontological societies coast-to-coast. A member of the Sociological Practice Association, the Society for the Study of Social Problems, and many related organizations, he is currently doing cross-cultural research focusing on changes in Sweden and the USA.

Trites, M.A., "Health Policy Development: Health Promotion and Illness Prevention Among Older Adults in Illinois," is Research Manager for Cook County Department of Public Health in Illinois. She earned her M.A. degree from Loyola University in sociology with an emphasis in health care. Her work encompasses all aspects of public health. She has made public health presentations for the Women Caucus; Latino Caucus; and Alcohol, Tobacco and Drug sections of the American Public Health Association's Annual Meetings.
