Submission of Manuscripts

Merrill-Palmer Quarterly serves as a source of new research studies in human development, theoretical papers, critical reviews of literature, and scholarly commentaries. The purview of *Merrill-Palmer Quarterly* encompasses theory and research on all areas of child and adolescent development, and incorporates the journal's historical commitment to the study of development in context. The Editors are primarily interested in submissions that advance developmental theory and generate novel findings from sound developmental methods and designs. Also preferred are empirical investigations that contain provocative aims, multiple studies, and innovative methods. Articles focused on technical issues (e.g., creation and evaluation of measures, statistical analyses, etc.) are of lesser interest unless they contain an original substantive (developmental) component. This same restriction applies to investigations that do *not* include infants, children, or adolescents as participants.

Manuscript Submission

Follow the instructions and specifications provided in the *Publication Manual of the American Psychological Association* (2010). The 6th edition of the APA manual may be purchased from APA Order Dept., P.O. Box 92984, Washington, DC 20090-2984 USA. Begin each of the following on a new page: title page, abstract, first page of text, references, appendix, footnotes, tables, figure captions, and figures. Double space *everything*, and please use 12-point font. Text should be left-aligned, not justified, and page numbers inserted at the top right corner for review purposes. Information about the authors (e.g., institutional affiliations, contact information, etc.) should be reported only on the title page (the information on this page will be removed by our editorial office before the blind review process begins), using the APA three-paragraph format (i.e., affiliations, acknowledgments, contact information). Blind review requires that information that might identify the author(s) be removed from all subsequent pages of the manuscript. Include an abstract that does not exceed 150 words in length. Most reports of empirical investigations that are considered for publication in *Merrill-Palmer Quarterly* do not exceed 30–40 pages, all inclusive (i.e., including references, tables, and figures). Submissions must be accompanied by a cover letter in which the corresponding author affirms that: (a) the manuscript (and findings) is not under consideration by another publisher or journal; (b) the study reported in this manuscript has been conducted in accordance with APA ethical guidelines. For studies that are part of a larger project, or have aspects in common with previously published articles, please explain how the various parts are related. The cover letter should contain contact information for the corresponding author: e-mail address, postal (street) address, and phone number. The corresponding author is responsible for keeping co-authors apprised of information pertaining to manuscript submission, review, and decisions. Cover letter and manuscript should be submitted electronically to <http://digitalcommons.wayne.edu/mpq> in MSWord format.
