About the Authors

Martin L. Abbott, “Looking Closely at Quality Circles: Implications for Intervention,” is Associate Professor of Sociology at Seattle Pacific University. Past director of the Criminal Justice Program at Pepperdine University, Dr. Abbott has current research interests in worker participation programs in business and industry.

Clifford M. Black, “The Sociological Practitioner as a Change Agent in a Hospital Setting,” is the Associate Dean in the School of Community Service at North Texas State University in Denton, Texas. He is a Licensed Professional Counselor (LPC) in the State of Texas, and a Certified Clinical Sociologist (CCS). He was instrumental in developing the first State Affiliate of the Clinical Sociology Association and establishing the first Ph.D. program with opportunities for training and experience in Sociological Practice and Clinical Sociology.

John G. Bruhn, “The Clinical Sociologist as a Health Broker,” is Dean of The School of Allied Health Sciences, Special Assistant to the President for Community Affairs, Professor of Preventive Medicine and Community Health, The University of Texas Medical Branch at Galveston, and Professor of Preventive Medicine and Community Health, The University of Texas School of Public Health in Houston.

Bryan D. Byers, “Uses of Clinical Sociology in Crisis Intervention Practice,” is an investigator for Adult Protective Services in South Bend, Indiana. His professional activities have focused on training and practice in crisis intervention, suicidology, and thanatology. He is also a deputy coroner. He has published in *Brain and Cognition*, *Emotional First Aid: A Journal of Crisis Intervention*, *International Journal of World Peace*, and *Professional Psychology*.

Richard A. Couto, “Participating Research: Methodology and Critique,” is the director of the Center for Health Services at Vanderbilt University, which conducts a series of programs to assist community leaders and residents in low income areas of the rural South. His previous publications and media projects deal with a range of issues related to poverty, regional development, and community organizing. His most recent book, *Streams of Idealism and Health Care Innovations*, is a study of student service-learning and community mobilization. Holman, "The Sociological Practitioner as a Change Agent in a Hospital Setting," is the director of the Criminal Justice Institute at North Texas State University, and is a Certified Clinical Sociologist (CCS). He administers an Inmate Rehabilitation Program at the Denton County Jail in Denton, Texas. In addition, he is actively involved in alternative sentencing programs and research in the state. He has experience working with NIMH and the Public Health Service.

Mark Kassop, "Salvador Minuchin: A Sociological Analysis of His Family Therapy Theory," is Associate Professor of Sociology at Bergen Community College in Paramus, New Jersey. He is currently a Family Therapy Extern at Bergen Pines County Hospital in New Jersey.
